

**Lab testing is done by third-party labs selected by the PCC and the test panel follows California standards, regardless of the states in which the product is sold. The test is done on the final product and not just the cannabinoid compound. Verification of the manufacturing facility certification does not require a physical visit to the location.*

The PCC has decided to step-in to not regulate, but instead evaluate quality, and verify product claims for the safety of consumers, and for the benefit of the industry.


